In 2015, Premier will again participate in Toys for Tots and the Thanksgiving Food drive. ASSOCIATE SPOLIGHT: DR. MOIRA BURKE

We start off the New Year with our Medical Director, Dr. Burke, who went to Honduras to provide services at New Hope Clinic. A team of 7 physicians provided help at the remote mountain community of Santa Fe where most of the people are indigenous Indian. The clinic was run by St. Petersburg Presbyterian through Palma Ceia Presbyterian Church.

"Our team were at a clinic in the remote mountains of Honduras. The medical specialties represented were pediatrics, internal medicine, gastroenterology, obstetrics and gynecology, as well as a dentist. The community had never before had an ophthalmologist. Previously they would travel 4 hours to the capital to see an ophthalmologist. I saw 225 patients in 5 days. We are very grateful to Premier for providing many spectacles." DID YOU KNOW?

Community Service is performed for the benefit of the public or its institutions. It is not the same as volunteering, since it is not always done voluntarily. Governments may require it in lieu of military service. Courts may demand it in lieu of, or in addition to, other criminal justice sanctions. Schools may mandate it to meet the requirements of a class, such as in the case of service-learning or for graduation. Many educational jurisdictions in the US need students to do community service to graduate from high school, and though not technically a requirement, many colleges require it for acceptance. Beginning in the 1980s, colleges began using service-learning as pedagogy. Many religious groups emphasize serving one's community.

At Premier, we call it community service though we give people the option to volunteer or not, however, it's still community service because it both helps the community and makes you a better person.
